b. **ITEM #3 DOMESTIC WATER TREATMENT AND FILTERING EQUIPMENT:** A license is not required for the installation of domestic water treatment and filtering equipment that requires modification to an existing cold water distribution supply and associated water piping in building if a permit is secured, required inspections performed, and the installation complies with the applicable code. If the enforcing agency determines a violation exists, the responsible installer shall correct it. The permit application shall include the application fee, the number of water treatment devices recorded @ \$5.00 each, and the appropriate water distribution pipe (system) size fee.

c. **ITEM #15, MEDICAL GAS SYSTEMS** shall include the application fee, one Special/Safety Inspection and the estimated number of additional inspections.

d. **ITEM #17 BACK FLOW PREVENTER, NEW INSTALLATIONS WILL BE CHARGED THE FEE IN #1 AND #17, CHECK ONLY WILL ONLY BE CHARGED FOR ITEM #17**

**X. INSTRUCTIONS FOR COMPLETING APPLICATION**

**GENERAL:** Plumbing work shall not be started until the application for permit has been received by the Ogemaw County Building and Zoning Department. All installations shall be in conformance with the State Plumbing Code. No work shall be concealed until it has been inspected. The inspector's telephone number will be provided on the permit form. When ready for an inspection, call this office providing as much advance notice as possible. Please have the Township and Permit Number when calling.

**EXPIRATION OF PERMIT:** A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within 180 days after issuance of the permit or if the authorized work is suspended or abandoned for a period of 180 days after the time of commencing the work. **A PERMIT WILL BE CANCELED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN 180 DAYS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELED PERMITS CANNOT BE REFUNDED OR REINSTATED.**
